#### Further information

- Each year, at least one “Assembly of Members” is held, to which all members of RASHID International e.V. are invited and where the future of the organization is discussed and decided. Supporting membership grants the right to attend and to speak, but **not to vote** during Assemblies. Supporting membership is intended as an option for organisations who wish to support RASHID International e.V. financially with little involvement in day-to-day affairs.
- Between Assemblies, members are informed about RASHID activities via e-mail through semi-regular membership briefings
- An institutional member may change their contribution level without being obliged to give a reason by 31<sup>st</sup> December of a given year which shall take effect the following fiscal year. Such requests shall be declared to the Board of Directors. Fees shall be payable by the 31<sup>st</sup> of March of a given year. For members joining during a year the fee for the first year is reduced by 50% if the application is received on 1<sup>st</sup> July or later.
